- ❖ Respect the bus driver, chaperones, and fellow students



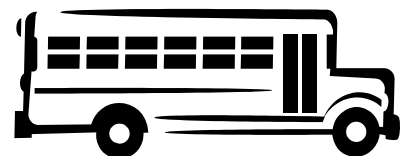
Consequences:

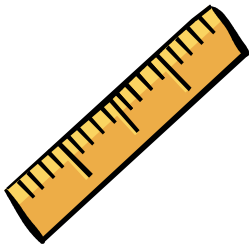




WONDERFUL WEDNESDAY AFTER SCHOOL RULES
